Disposal & Recycling:

All spills must be cleaned up or track fines may occur. Safety-Kleen waste stations are available throughout the paddock.

Starting Light Systems/Standing Start Practice:

Standing start practice will be available during official practice. All new drivers must complete at least two practice starts prior to qualifying.

Radio Frequency:

All teams are required to monitor the Race Control Frequency: 466.3875 DPL 664. All teams must also register team radio channels two weeks before the event.

Driver/Crew Attire:

All team members including the driver are expected to be in complaint F4 team apparel when at the track. Any teams in violation of this are subject to monetary and competition penalties.

Pit Lane After Qualifying and Race:

All cars must report to parc ferme after qualifying and the race. Cars will not be permitted to stop in their pit box upon the completion of qualifying and the races.
